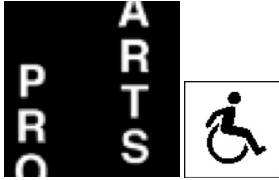

Registration is on a first come, first served basis. **Registration for all visual artists (both members and non-members) will begin at 8 am on March 1. The cost to participate as a Pro Arts member is \$15 for the first review and \$30 for each additional review. Members of the public are invited to register for \$45 per review.** Non-members who register for 2 or 3 reviews get one year free Pro Arts membership (artist-membership subject to approval from Membership committee). Artists can register for up to 3 reviews.

Participating artists also have an opportunity to be selected for the Curator's Choice exhibition in May 2019.
